



STAND TOGETHER: Supporting children's social and emotional wellbeing in schools

- All information stored securely and confidentially and only the research team have access to it
- Researchers who come into your school will have enhanced DBS checks
- Individual teachers, pupils, schools or other people never identified in any reports

- Your school's KiVa coordinator and KiVa Team Lead attend a **two-day** training course (teacher supply cover **not** covered by funding)
- They train all other school staff and take charge of rolling out the programme in your school

- KiVa antibullying programme:
- **45 minute** class lessons each **fortnight**
 - Fill in Lesson Log Book (**5 minutes** each lesson)
 - Online games for pupils
 - KiVa Team use scripted processes and forms for dealing with bullying
 - Schoolwide components e.g. assemblies, posters and vests
 - Covers over half of PSE/PSHE
 - Lesson plans and materials are all provided
 - A researcher may visit your school to watch a KiVa lesson
 - **Costs covered by research funding (usually £600-1000)**



January 2020
 Researcher visits the school to meet with Headteacher and enrol the school in the trial (**30-45 minutes**).



February-April 2020
 Researcher visits the school to administer questionnaires to KS2 pupils and teachers (**1-2 hours**). Researcher collects information from school administrator (**30-45 minutes**) and (assistant/deputy) Headteacher (**30-45 minutes**).



March-April 2020
 Randomisation occurs and Headteacher is notified of the outcome.

We want to compare the KiVa antibullying programme with usual policies, so only half of the schools in the trial will be randomly selected to receive the KiVa programme and half of the schools will be randomly selected to continue with usual antibullying practices.

KiVa antibullying programme

Usual antibullying practices



May-June 2020
 Receive KiVa training and prepare to roll out programme in school. Receive information on trial procedures.

May-June 2020
 Receive information on trial procedures.



September 2020 - July 2021
 Deliver KiVa antibullying programme within the school.

September 2020 - July 2021
 Continue with normal antibullying practices.



May-June 2021

- Researcher visits school to administer questionnaires to KS2 pupils and teachers (**1-2 hours**)
- Researcher collects information from school administrator (**30-45 minutes**) and (assistant/deputy) Headteacher (**30-45 minutes**)
- Parents asked to fill in a short survey (**10 minutes**)
- Some staff, teachers and pupils may be randomly invited to take part in interviews (**45 minutes**)

May-June 2021

- Researcher visits school to administer questionnaires to KS2 pupils and teachers (**1-2 hours**)
- Researcher collects information from school administrator (**30-45 minutes**) and (assistant/deputy) Headteacher (**30-45 minutes**)
- Parents asked to fill in a short survey (**10 minutes**)
- Some staff may be randomly invited to take part in interviews (**45 minutes**)



All schools who participate in the trial and provide data are eligible to receive a **maximum of £308** for helping researchers gather information. Schools in previous projects used their participation as positive evidence to support teachers' professional learning.

Schools in the Usual Practice Group that are interested in being trained in KiVa after the trial can contact the researcher for more information and options for funding.
